Robert McCorquodale is a member of the United Nations Working Group on Business and Human Rights and a practising barrister and mediator. He was a Professor in Law Schools for nearly 25 years and has been ranked as an "eminent practitioner" in business and human rights by Chambers & Partners Global Rankings. Robert McCorquodale was the representant of the UN Working Group on Business and Human Rights during its visit in 2022 in Luxembourg, and which led to the presentation of its final report on Luxembourg to the Human Rights Council in June 2023.



Dr. Başak Bağlayan works as an expert on Responsible Business Conduct (RBC) at Luxembourg's Ministry of Economy. She also serves as the Secretary General of Luxembourg's OECD National Contact Point for RBC. Previously, Dr. Bağlayan was a researcher at the University of Luxembourg, where she earned her PhD in law with a specialization in business and human rights. In addition to her academic publications, she has drafted various policy papers on RBC for the government of Luxembourg, as well as for the International Labour Organization and the United Nations Development Programme Turkey offices.



Eduardo Mosqueda is a human rights lawyer from Mexico, and Executive Director of Tsikini. He is a member of the Council of the Federal Mechanism for the Protection of Journalists and Human Rights Defenders in Mexico. He is versed in the legal defence regarding megaprojects of development in urban and rural communities, as well as the protection of human rights defenders and promotion of human rights through education for sustainability and participation in the creation of public policies.

His organisation Tsikini is member of the Fair Steel Coalition and as such he participated in the presentation of the report" The real cost of steel" in Luxembourg in April 2024.



Marion Lupin is a policy officer for the European Coalition of Corporate Justice, where she works on national coalition building and EU HRDD advocacy. Prior to working for ECCJ, she worked as Advisor in EU Affairs for the Belgian Confederation of Liberal Trade Unions, where she focused on company law and corporate governance, international labour standards and human rights due diligence. She also has experience with the dynamics of corporate legal environments and EU advocacy thanks to her previous work for the European Company Lawyers Association (ECLA). In line with her French-Italian background, she graduated from Université Paris I Sorbonne and Università degli Studi di Firenze with a double Master in Italian and French law.



Caroline Omari Lichuma is a Postdoctoral Researcher, Centre for Human Rights Erlangen-Nuremberg (CHREN). Her current research is in the broad area of Business and Human Rights, with a particular interest in regulatory developments at the national, regional and international levels. She received her PhD in International Human Rights Law (Summa cum laude) from the Georg-August University of Göttingen in Germany, her LLM in Public International from the New York University and her LLB from the University of Nairobi. In November 2023 Caroline was appointed as co-rapporteur of the International Law Association's newly established Business and Human Rights Committee. She also co-edits the Business and Human Rights Journal blog.



Since November 2020, **Francesco Tramontin** leads as Vice-President Global Public Affairs - Institutional Affairs & Corporate Communications Europe FERRERO the newly created Group Public Policy Center and EU institutional relations teams for the Ferrero Group. His focus on promoting the company's external engagement strategy on sustainability, responsible marketing and health and nutrition.
